MEMORANDUM OF UNDERSTANDING

AND

The **ENACTUS**, **SRI AUROBINDO COLLEGE**, **MALVIYA NAGAR**, **NEW DELHI** and represented herein by Mr. Hittesh Kumar, Secretary, for Project Haritha and herein after referred to as ENACTUS, SRI AUROBINDO COLLEGE.

WITNESSETH

WHEREAS, CIBART is a not-for-profit networked organization incorporated in 2002 under Section 8 formerly Section 25 (non-profit organization) of the Indian Companies Act, 1956, dedicated to the development of the bamboo sector in India, with several daughter and partner organizations and enterprises in districts in several states in India and overseas;

WHEREAS, CIBART was set up to promote bamboo production in India and has developed strength in various functional areas such as bamboo based livelihoods, resource inventory, resource development and management, innovative bamboo technologies, capacity building and training, establishing and operating common facility centres, developing technology protocols/ patents and product/application development, biomass and charcoal briquetting, biomass gasifier power production, crafts/furniture, construction and boats building, policy research, monitoring and evaluation systems, marketing, product design and development, and community development;

WHEREAS, ENACTUS-SRI AUROBINDO COLLEGE, which is a student-led Society of the College, which comes under the umbrella of the International Organization, Enactus.

WHEREAS, ENACTUS-SRI AUROBINDO COLLEGE, which works in social sector and propelled to achieve newer milestones with sustainable and eco-friendly approach.

NOW THEREFORE, motivated by their common interest in the use of bamboo in the production of sustainable and eco-friendly products, ENACTUS-SRI AUROBINDO COLLEGE will collaborate with CIBART in the Skills improvement area of the community residing in a few pockets of New Delhi, NCR and agreed to work together as defined in a Memorandum of Understanding even dated and also to enter into specific arrangements to cover specific

interventions under the **PROJECT HARITHA**. Further, both parties have agreed as follows, subject to the availability of human, financial and other resources, on the general conditions as herein contained.

Article I Objective

The objective of the present MOU is to achieve common goals of developing the necessary skills in the community in the bamboo products making, and to do so in a manner financed through a project grant.

Article II Collaboration

Subject to the terms and condition of this Memorandum of Understanding (MoU), ENACTUS-SŔI AUROBINDO COLLEGE and CIBART agree to undertake a three days' workshop on Bamboo Products Making tentatively from 26th to 28th September 2022.

CIBART has agreed to provide technical support and trainer services for the said period and to ensure the Project is implemented successfully. Further, it was agreed to provide Expert Trainer services in the making of spoons, forks and small bamboo products.

Enactus-Sri Aurobindo College, has agreed to arrange for the venue to conduct the workshop, supply the necessary raw materials viz. bamboo poles (bijli), small tools like knife, daav, inch tape, scale etc., consumables like sandpaper, fevicol etc., and providing the safety gloves, drinking water and hygiene sanitation facilities to the trainer and the community.

Article III Operational Agreements

Now Therefore, the parties hereby agree as follows the functional and operational points under this agreement:

Both CIBART and Enactus-Sri Aurobindo College shall be fully responsible to each other for the due timely performance of all obligations described to them under this MOU.

Article IV Payment

Enactus-Sri Aurobindo College shall pay CIBART a sum of Rs. 8,000/- + 18% GST for the trainer charges, accommodation, food and travel expenses; Article V

Entry into Force and Term

This Agreement shall enter into force upon signature by both parties. The validity of this Agreement shall be for 30 days.

CIBART's Chief Operating Officer shall be its designated representative in matters related to this Agreement. Likewise, Enactus-Sri Aurobindo College's Secretary shall be its designated representative.
