

MEMORANDUM OF UNDERSTANDING

This MOU is executed at Project Haritah: Enactus Sri Aurobindo College, University of Delhi on this 1st day of October 2022, between Enactus Sri Aurobindo College (as the "FIRST PARTY") and Indian Pollution Control Association with its office at 450/1/B-1 Street No. 14-A, Shahdara, Delhi – 110 032 (as the "SECOND PARTY") Whereas the First Party has approached the Second Party to undertake the project of Plastic Waste Management at their college on their behalf. The agreement is made initially for ONE year and may be extended further on mutual agreement after ONE year on revised terms and conditions (if any).

And whereas the Second Party has expressed its willingness to accept this offer made by the First Party.

Now therefore it is agreed between the two parties as under:

A. The First Party will do the following jobs:

1. They will ensure collect the segregated plastic waste and store it in a common place.
2. They will do some awareness program related to the campaign.
3. They will inform at least two day before for the collection of the plastic waste.
4. They will give at least one week time to arrange the recycle product as per their requirement.

And

B. The Second Party will do the following jobs:

1. IPCA will collect Plastic Waste from the common point of first party college Enactus Sri Aurobindo College, University of Delhi on once in a week basis.
2. IPCA will collect the segregated plastic waste and do the further segregation as per the different categories of plastic at their cost.

3. To collect the segregated plastic waste, they will send their commercial vehicle with minimum one waste collectors for loading the waste material.
4. They will be responsible for the recycling of collected plastic waste through authorized recyclers at their own cost.
5. IPCA will provide Certificate in the name of First Party (Enactus Sri Aurobindo College and Only Sri Aurobindo College).
6. The Second Party neither pay nor charge from the First Party for its services.
7. Either party can terminate this MOU by giving one month notice in writing.
8. Students will purchase the products (Products- Key chains, examination board, Bird house) from IPCA T&C.
9. This agreement is for a period of ONE year from the date hereof.

ENVIRONMENTAL AND ETHICAL COMPLIANCE

IPCA shall also comply with all applicable legislation, rules, regulations or orders relating to environmental management and any internationally recognized standards or Green Partner policies for ethical environmental management. Green Partner may, where appropriate, request improvements in IPCA practices to ensure compliance with the said principle. Further, IPCA shall implement an environment management system (EMS) based on the principles of ISO 14001 standard or similar international standard. IPCA shall encourage the adoption of the principles therein by its subcontractors.

This MOU is signed at New Delhi on this 1st day of September 2022 in the presence of the witnesses shown against each.
