

MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (MoU) is made on the 27th day of July, 2024, by and between:

and

the placement cell of **Sri Aurobindo College, University of Delhi** located at Shivalik, Malviya Nagar, New Delhi-110017, hereinafter referred to as the "Placement Cell".

Purpose:

The purpose of this MoU is to establish a collaborative partnership between InGelt Study Abroad and the placement cell to provide students with the opportunity to pursue higher education abroad. This collaboration aims to facilitate the application process, provide necessary resources, and offer support services to students aspiring to study abroad.

Scope of Collaboration

1. Responsibilities of InGelt Study Abroad:

- Provide expert guidance to students seeking international education opportunities.
- Organize and conduct seminars with foreign college representatives to provide firsthand insights to students.
- Offer personalized university and course shortlisting through experienced country-specific counselors.
- Streamline the college admission process leveraging established relationships with over 1500 universities in 30 countries.
- Facilitate education loans through partnerships with 16 top banks in India.
- Assist with visa filing through registered immigration consultants.
- Provide accommodation services in over 250 cities worldwide.

1. Responsibilities of the College:

- Promote the partnership with InGelt Study Abroad among students.
- Facilitate the circulation of registration forms to interested students.
- Provide logistical support for seminars and meetings organized by InGelt.

Duration and Termination

This MoU will remain in effect for a period of one (1) year from the date of signing and may be renewed upon mutual agreement of both parties. Either party may terminate this MoU with thirty (30) days written notice to the other party.

Confidentiality

Both parties agree to maintain the confidentiality of any proprietary or sensitive information shared during the course of this partnership.
