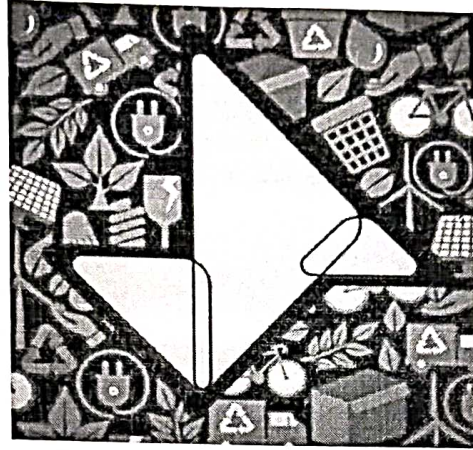


MEMORANDUM OF UNDERSTANDING

Thrive Together NGO
[Party - 1]

And

Enactus Aurobindo
[Party - 2]

This Memorandum of Understanding came into force on 04/07/24 between Thrive Together NGO [Party 1] and Enactus Aurobindo. [Party 2]. This document is precisely designed to establish a collaborative working framework to conduct a Long Term Collaboration for 2 months which will endeavour to accomplish the goals of societal welfare and the blossoming of the communities.

● PURPOSE:

The purpose of this MOU is to officially establish and record the collaborative endeavours and obligations to be followed by both parties. Both parties agree to work in unison to initiate the Long Term Collaboration for 2 months.

● OBJECTIVES:

Party 1 and Party 2 have agreed to the following objectives for the collaborative Extracurricular activities drive.

1. Volunteers from both the parties will reach the centre 10 minutes prior.
2. Equal contributions from each party if required for any drive.
3. 4 volunteers from each side are required.
4. Clicking pictures with children and the volunteers from both parties.

● CONTRACTUAL TERMS:

● *Party 1 will provide the following-*

1. Volunteers (4)
2. Funds- If required for any drive

● *Party 2 will provide the following-*

1. Volunteers (4)

● DURATION:

This MOU shall come into effect on 04/07/24 and shall remain in force till 04/08/24 unless terminated earlier with mutual agreement. Activities will start from August and date will be decided with mutual discussion before the visit.

● RULES FOR THE DRIVE:

1. Both parties are required to reach the location 10 minutes prior to the decided time to avoid any kind of delay in the initiation of the drive.

2. Both parties are expected to ensure proper management while conducting the drive. Any breach of conduct or misdeed shall be avoided.
3. Both parties should have the resources/items as promised for the drive.

● **GOVERNING LAW:**

Any disputes arising out of the MOU shall be resolved through negotiation by both parties, before going ahead with any legal action.

As a witness, the undersigned representatives of Thrive Together NGO and Enactus Aurobindo. Organization, hereby declare the execution of the MOU on the date mentioned above.

● **STATEMENTS AND ASSURANCES:**

Both parties hereby declare that they are fully authorised to enter and sign the MOU. The duties and accountability of either of the parties shall not contravene the rights and obligations of the other party, nor should it cause harm to any third party, or any other entity or organisation whatsoever.

● **LEGALITY OF THE AGREEMENT:**

This Memorandum of Understanding shall be binding on both parties. Both parties agree to the terms and conditions as outlined above.

This agreement shall come into action once the representatives of both parties have exhibited and the signed document is sent via mail.
